#### **Truck Update**

Jim Ebner informed the Commissioners that the spec is 95% done, a lot of verbiage needed to be fine-tuned. It was forwarded to the representative and as of today the only correspondence from the Rep has been was wanting to know when we can meet.

Commissioner Centofanti spoke to the Rep and a meeting is set for next Thursday at the district meeting room to finish the spec.

Rescue Committee: Mike Terracino reported that they have been meeting twice a month. They have been looking at different rescues. We are moving very quickly on this and need a time frame of when we can order the rescue and the perimeters of what you may want or not want. The Commissioners discussed doing a permissive referendum in 2019 with the Rescue being built in 2020.

## Fire Police Badges

The Commissioners discussed ordering newfire police badges. Currently some say Monroe Joint Fire District and some say Monroe Fire Dept. Commissioners decided that at this time 3 badges are to be ordered and they will say Monroe Fire Dept.

### **New Building Update Station #2**

Commissioner Kalter reported that the following items have been completed by Hush Electric: flag pole lights, parking lot lights and power has been run to the sign. The compressor is hooked up and now Haight has to come in and place it in its final position and service it. Ashley Mechanical adjusted the water temperature Now that we have received our certificate of occupancy DOC's Cleaning Co. can start cleaning the building. Assistant chief Lenahan stated the water by the sink in the short bay is not getting hot.

Commissioners Kalter stated that Ashely is aware of the problem with the thermostat in the attic, but the person is hard to get ahold of.

Commissioner Kalter and Commissioner Smith met with DOC Cleaning Co. to get a price for cleanup of the building due to the fact Meyer Contracting never did the final clean up. DOC Cleaning Co gave a verbal price quote was less than \$3,000.00 more than likely be right around \$2,800.00 for a deep cleaning of the fire house from top to bottom with the acceptation of the apparatus floor, after that cleaning they would start their contract for the general cleaning of the station.
